- Ensuring those affected by endometriosis are productive, feel valued in their workplaces, and nurtured to succeed in their places of study
- Building a strong, connected community network amplifying the voices of those affected by endometriosis
- Ensuring lived experiences of those affected by endometriosis informs policy development and health system change
- And other relevant support and assistance.

PURPOSE OF THE ROLE

- 1. To hold the vision of Insight Endometriosis, and work with Board and staff to review and achieve the Mission, Goals, Objectives and Strategic Plan.
- 2. To develop and maintain governance policies that support the work of the Board and oversee the operational policies which support the work of the charity.
- 3. To support the Chair in ensuring Insight Endometriosis has good governance.
- 4. To monitor the progress of staff in achieving strategic objectives, and to provide support and guidance as appropriate.
- 5. To approve and monitor the annual budget.
- 6. To assess and monitor organisational and strategic risks.

MAIN RESPONSIBILITIES AND EXPECTATIONS

The Chairperson is responsible for:

- Leading strategic planning
- Managing relationships with Management
- Ensuring risks to the organisation are managed
- Encourage all trustees to contribute to the debate and decision making
- Manage Board processes at meetings

Trustees are expected to:

- Board meetings: Prepare for and actively participate in monthly Board Meetings
- Board Activities:
 - Participate in planning and monitoring of the Strategic Plan.
 - Participate in development of Governance policies, and have oversight of operational policies
 - Approve and monitor the annual budget, review the financial statements and ensure the financial viability of the organisation.
 - Ensure compliance with trust deed, charities registration requirements, privacy, employment and other enactments.
 - \circ $\;$ Contribute support and advice in individual areas of expertise.
- Be familiar with and follow the requirements of the 2019 Trusts Act including:
 - the five mandatory duties: know the terms of the trust; act in accordance with the terms of the trust; act honestly and in good faith; act for the benefit of the beneficiaries or to further the purpose of the trust and exercise their powers for a proper purpose.
 - the 10 default duties: exercise reasonable skill and care; invest prudently; not exercise trustee powers for their own benefit; consider their exercise of power; not bind trustees to a future exercise of discretion; avoid conflicts of interest; act impartially; not profit from their position; not act for reward; act by consensus.
- Employment: Through the Chair, be a responsible employer with good employment practice.
